# FLOTILLA QUALIFICATIONS INDEX

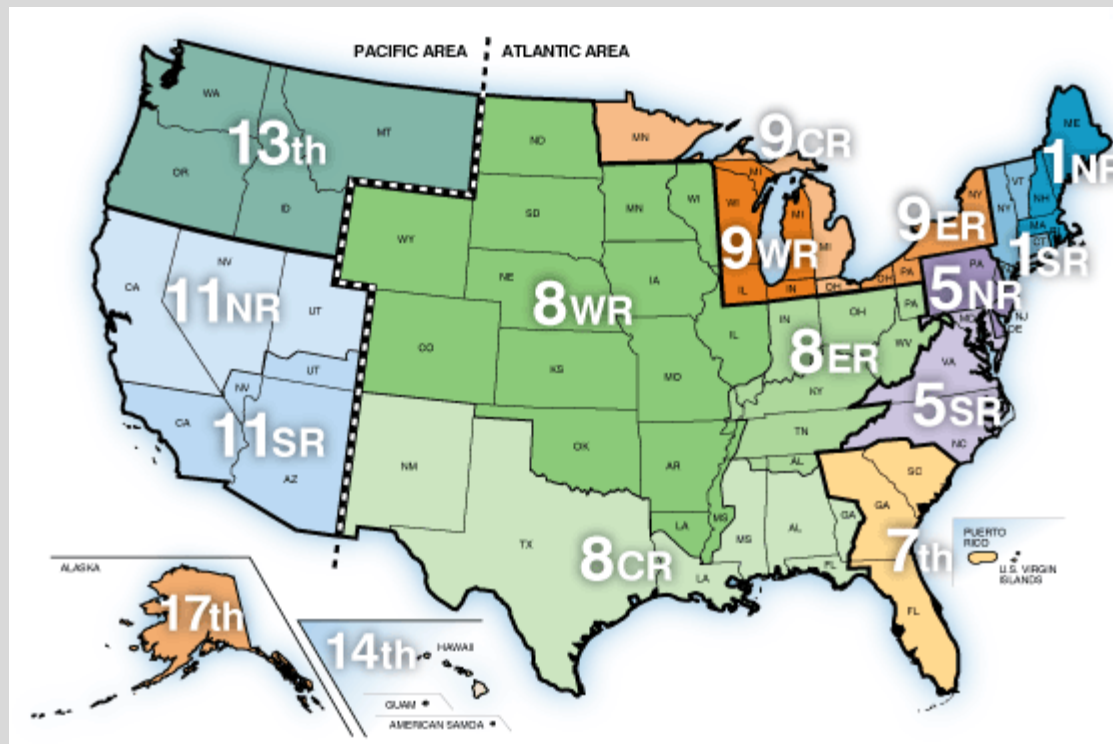
Like the FPI, the FQI is a snapshot measure.  
It is only computed for the most recent calendar year.



# FLOTILLA QUALIFICATIONS INDEX

Works just like the FPI computation.
